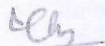
Sub : Issue of Certificate of Recognition to the Schools under sub-rule (4) of rule 13 of the Odisha Right of Children to Free and Compulsory Education Rules, 2010 and under Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir / Madam,

With reference to your on-line application no. 12180/2022 and subsequent correspondence with the school / inspection in this regard, I convey the grant for issuance of Certificate of Recognition to the Kanak Manjari International School, Chhend Colony, Rourkela name of the school with address) for Class-I to Class VIII for a period of five years w.e.f. dtd.01.04.2022 to dtd.31.03.2027.

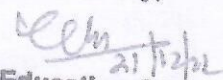
The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize / affiliate beyond class VIII.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Odisha Right of Children to Free and Compulsory Education Rules 2010.
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society / School shall nor collect any capitation fee and subject the child of his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission.
7. On the ground of religion, caste or race, place of birth or any of them.
8. The School shall ensure:
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Every child completing elementary education shall be awarded a certificate as laid down under Rule 22.
 - e. Inclusion of Students with disabilities / special needs as per provision of the Act.



- f. The teachers are recruited with minimum qualifications as laid under Section 23(1) of the Act.
- g. The teacher performs its duties specified under Section 24(1) of the Act and
- (xxii) The teachers shall not engage themselves for private teaching activities.
9. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
10. The School shall enrol students proportionate to the facilities available in the school as prescribed in the Section 19 of the Act.
11. The School shall maintain the standards and norms of the school as specified in Section 19 of the Act. The facilities reported as the time of last inspection are as given under:-
 - Area of school campus
 - Total built-up area
 - Area of play ground
 - No. of Class rooms-
 - Room for Headmaster-cum-office-cum-storeroom
 - Separate toilet for boys and girls-2
 - Drinking Water facility-Pipe Water with Acquiguard-Yes
 - Kitchen for cooking Mid Day Meal
 - Barrier free access-Yes
 - Availability of Teaching Learning Material / Play Sport Equipments / Library-Yes
12. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
13. The School buildings or other structures or the grounds are used only for the purposes education and skill development.
14. The School is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force;
15. The School is not run for profit to any individual, group or association of individuals or any other persons;
16. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.
17. The recognition Code Number allotted to your schools is SNG/DEO/313. This may please be noted and quoted for any correspondence with this office.
18. The School furnishes such reports and information as may be required by the Director, Elementary Education / District Education Officer / Block Education Officer as the case may be from time to time and complies with such instructions of the State Government / Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the schools;
19. Renewal of Registration of Society if any, be ensured.

With reference to your application dated 10-2-2022 and subsequent school inspection in this regard, I hereby convey the grant of Recognition to KANAK MANSARI INTERNATIONAL SCHOOL, ROURKELA (Name & Address of school) for class I to VIII standard for the period 05 (no. of years) from the academic year 1-4-2022 to 31-3-2027 in compliance to section 18 of Right of Children to Free and Compulsory Education, Act, 2009 & rule 13 of RCFE of section 18 of RCFE 2009 (State Act/ Rule).

The above recognition is subject to the following conditions:-

1. The temporary recognition accorded to the school is valid from the academic year 1-4-2022 to 31-3-2027 and is to be renewed at an interval of every 05 years.
2. The grant of recognition is available initially for classes I to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Odisha RCFE 2010 (State Education Act/ Rules).
4. The school shall admit in pre-school / class I to the extent of 25% (percentage) of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
5. The school shall maintain a separate bank account for the purpose of reimbursement.

6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
7. The school shall not deny admission to any child, -
 - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b. On the ground of religion, caste or race, place of birth or any of them.
8. The school shall ensure that,-
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Inclusion of students with disabilities/ special need as per provision of the Act..... (rule/ clause of State Act).
 - e. The teachers are recruited with minimum qualifications as laid under 23(1) of the Act. (rule/ clause of the state Act).
 - f. The teachers perform his duties specified under Section 24(1) (rule/ clause of the state Act).
9. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
10. The school shall maintain the standards and norms as specified in Section 19 (rule/ clause of the state Act).
11. No unrecognized classes shall run within the premises of the school or outside in the name of school.
12. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
13. The school is run by a society registered under the Act 1860 (21.4.1860) Act under with Society is registered), or a public trust constituted under any law for the time being in force.
14. The school is not run for profit to any individual, group or association of individuals or any other persons.
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
16. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
17. DR. I. A. A. (language subject) shall be taught as a subject from in standards I to X in all schools notified under Act..... (concerned Act/ rule) from academic session recognition is granted.

18. The school shall abide by the provisions of the OE Act 2009 (State Act/ Rules).
19. The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/ time.
20. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
21. The management shall apply for renewal of recognition three months before the expiry of this order to this D.E.O., Sundargarh (Name & Address of the certificate issuing authority).
22. The management shall follow the directions issued by the Government/ Department from time to time keeping in view of the safety and security of the children and the overall administration of the school.
23. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.
24. The school management shall have to full responsibility if any court cases arises this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the D.E.O. BASK (Concerned State Authority).
